Updates on various boards/commissions/activities: Supv Keifer attended FMC Landfill, Joint Entity and Freesoil Foundation meetings. Supv Kuhn attended an Area Development Corp Asset Management meeting.

Updates on Law Enforcement Center/Courthouse (LEC) Project: Keifer is working on HVAC and water softener issues.

Keifer/Jorgensen moved to approve Change Order #2 with Motorola Solutions for a \$10,400 credit on 13 radios at \$800 each whereby Motorola ordered dual band radios that should have been single band radios and the county agreed to keep them as delivered. Motion carried 3-0.

Jorgensen/Keifer moved to approve an Agreement Between North Iowa Area Council of Governments and Floyd County for providing planning and zoning services effective April 1. Motion carried 3-0.

The Board noted the hiring of Sara Butterfield, Home Care Aide, starting at \$16/hour effective March 12, with a potential \$0.50 wage increase after a 6-month probationary period.

Jacob Page, County Engineer, provided a bid tabulation for the 2024 Rock Resurfacing project with only Bruening Rock Products bidding. Jorgensen/Keifer moved to accept the bid for the 2024 Rock Resurfacing project from Bruening Rock Products for \$15.279/ton with 100,000 tons, totaling \$1,527,900. Motion carried 3-0.

Jorgensen/Keifer moved to go into closed session pursuant to Iowa Code 21.5(1)(j) to discuss the purchase of a particular real estate only where premature disclosure would be reasonably expected to increase the price the government body would have to pay for that property. Roll call vote: Jorgensen, Keifer, Kuhn; motion carried 3-0.

The board went into closed session with Attorney Todd Prichard and Ben Chatfield at 9:20 a.m. The board returned to open session at 10 a.m.

Kuhn/Keifer moved to accept an offer from Stephen Schlader's offer of \$70,000 for a 1.5-acre parcel for the communications tower and 25% of any rental on the tower for 30 years and authorize the county attorney to prepare a purchase offer. Motion carried 3-0. Prichard will prepare a purchase offer to Schlader as the seller and the county as the buyer with a lease/share position.
