Jorgensen/Keifer moved to approve the agenda. Motion carried 3-0.

Auditor Carr presented canvass materials including election night reports, precinct tally books, write-in tally, and abstracts for review.

Keifer/Jorgensen moved to approve Res #15-24* Certification of Floyd County Election Results: The Supervisors/ex-officio Board of Canvassers canvassed the vote of the Primary Election held as prescribed by law on June 4, 2024 in accordance with §50.24 of the *Code of Iowa*; the Board noted a discrepancy in the number of voters and the number of ballots issued at a precinct whereby a voter's spoiled ballot was entered into the tabulator and was erroneously issued another ballot causing a the count of ballots voted to be one higher than the number of voters. Be it resolved that the Board hereby certifies the voter turnout, the Canvass and results for the Primary Election held June 4, 2024 as follows:
