The Board of Supervisors met at 8:30AM on Tuesday May 28th 2024 at the Franklin County Courthouse with Board members Vanness, McVicker, and Lukensmeyer present.

Motion by Lukensmeyer, seconded by McVicker to approve the Agenda as presented. All ayes. Motion carried.

Motion by McVicker, seconded by Lukensmeyer to approve the regular board minutes & drainage minutes dated 5/20/2024. All ayes. Motion carried.
