April 7, 2025, 9:00 a.m.

The Floyd County Board of Supervisors met in the Board Room of the Floyd County Courthouse. Supervisors Dennis Keifer, Boyd Campbell, and Gloria Carr were in attendance.

Carr/Campbell moved to approve the agenda. Motion carried 3-0.

Updates on various boards/commissions/activities: Carr worked on FY26 Decat budget. Keifer attended Open Meetings/Ethic Law training, Department Head and Washing School Watershed meetings and made calls regarding a county right of way ordinance. Campbell attended the Shell Rock River Watershed Management Coalition Meeting. All three supervisors were provided information on a proposed rail project.

Gail Arjes, Public Health Director, provided an update on Public Health department activities. The board discussed Public Health taking on General Assistance.

Adam Sears, Conservation Director, provided an update on the Conservation department activities.

Travis Bartz, Lt Deputy Sheriff, presented a company called Pyramid Network Services, LLC to oversee and manage the leasing tower space at the Rockford site.

Campbell/ Carr moved to approved payment of \$395.18 to Ahlers Cooney for Judicial Review of IUC for Summit Carbon Solutions Permit. Motion carried 3-0.

Carr/Campbell moved to approve payment of \$346,048.20 to Motorola for Communication Tower to be paid for with Tower Project Bonds. Motion carried 3-0.

The board noted a corrected retirement date of April 4 for Sheriff's deputy, Brian Tiedeman.

The board discussed establishing a more formal policy than what is provided in the employee handbook for closing of county buildings for situations such as inclement weather. Adam Miller, County Engineer noted that keeping the courthouse open during a "travel not advised" warning is counterintuitive to keep the courthouse open and inviting people in, as it poses safety risks to both the community and county employees.

Future agenda items: Drainage District 3, Washington School Watershed, General Assistance, new phone system, Floyd County's Iowa DOT 5-year plan, and recertifying IT Director wage.

The board discussed FY26 budget items including updating the general assistance budget and preparing the FY26 budget hearing notice.

Carr/Campbell moved to adjourn. Motion carried 3-0.
