Updates regarding various boards, commissions, and activities since the last meeting: None.

Shawn Monahan, Corebridge Financial, joined the meeting to answer questions and explained the process of joining the Iowa RIC plan that was discussed in the October 28 meeting. Carr/Campbell moved to authorize Shawn Monahan to contact the Iowa RIC Plan to obtain a service agreement and proceed with enrollment. Motion carried 2-0.

The Board noted the retirement of Jolene Patterson Treasurer's Driver's License Deputy effective December 19, 2025.

The Board discussed the importance of keeping the driver's license department open in Floyd County and agreed the Treasurer should proceed with hiring a Treasurer's Clerk.

The Board noted the retirement of Dale Hughes, Secondary Road Motor Grader Operator effective December 4, 2025.

Deputy Travis Bartz reintroduced the need for new laptops and cameras, presenting Baycom's \$52,536 quote with possibly \$10,000 covered by a grant. Deputy Luke Chatfield shared Axon's \$422,124 quote for body and in-car cameras with a 10-year service agreement, expiring December 15 and likely to increase by \$100,000. The Board discussed funding options, including bond proceeds, pending input from the 911 Board on Thursday. No action was taken.

The Board noted the Central Iowa Juvenile Detention Center FY23 Audit.

Future agenda items: Law Enforcement 28E mayor meeting, TIF/Debt Certificate approval, an update on the phone system, and a letter from Senator Salmon and Representative Thomson.

Carr/Campbell moved to adjourn. Motion carried 2-0.
